Model of ideal strategic managed sustainable development enabling implementing the 2030 Agenda by countries at global UN coordination at promoting existence, SD, peace, human rights including by education with solving problems as on peace, nuclear weapons, equality, migration, climate change, financing, accelerated by integrated UN and intergovernmental agendas&agreements&structures. It reflects rules of human existence within the Earth environment with attributed territorially raising global management keeping them including strategic human equality at most effective equilibrated use of environment&climate as matter&energy (E&C) -inclusiveness-integration, responding to the SDGs groups, securing existence in time. Precises&unifies country-relevant corporate and national accounts & GDP & budget model&system (CNAM) as universal managed mechanism of own development & cooperation, with making it an universal information&operational tool for the 2030 Agenda

Ideal sustainable development by the model. It should be realized as top down managed&bottom-up fulfilling of more ideal than before equal fixed defined set of existential needs at fixed defined set of determining conditions: most effective equilibrated use of E&C, inclusion of all, support for structuring&equalizing (so responding to SDGs groups SDG10&SDGs1-9, SDGs11-15, SDG16, SDG17), by life length closed institutional (as in CNAM) X-Y blockchained grid like system consisting of set of vertical knowledge&work&age referred leveled structures education/youth-manufacturing&teaching&research/adults-summarrizing/elders, delivering particular (goods&services) and results of keeping the conditions, with contributions and quantities of E&C (if relevant) and knowledge and work of individuals involved from their identifiable measurable systems (and new knowledge results), interlinked horizontally by levels, tackled as in CNAM, with attributing money to contributions and securing it enough for equal fulfilling the needs with surplus for future realizing, with raising territorially extendable management, actually by regions, countries, global, securing territorial equality of needs at parallel conditions regarding different allocation of E&C and individuals and inter-territorial horizontal shifts of components also individuals in levels. It should be realized as repeatable mechanism; identification-planning-realizing-checking; then improved realizing by more precise&new knowledge; with common strategy of improvement, by common targeted policies responding to SDGs groups, by unified extendable CNAM, with important structuring-equalizing policy&programs&institutions.

Realizing the 2030 Agenda by the model. As the SDGs respond to ideal ones required for ideal global sustainable development, their global achieving is possible by striving to them according to the model, by parallel unified functioning of regions and countries and global coordination by and within territorially attributed extendable unified managed CNAM, with the same top down managed& bottom up realizing, by annual improvable planned&settled realizing, with measuring progress by indicators of the Agenda even more precised. Realizing would require precising&unifying the law and standards including on measuring especially knowledge and work along with information and promotion to all on model development including by education to give awareness and to allow realizing. The model allows to explain fundamental aspects of human development as existence as the key aim, in peace, imperatives of equilibrium of matter&energy of E&C and of precise measuring, human rights&obligations, equality as basic right and goal with mobility as form of its realizing, and to solve operationally the problems.

Accelerated realizing the 2030 Agenda by making use of integrated subject UN& intergovernmental agreements&structures. It would be possible to implement the 2030 Agenda by such pioneer structure - of the to be adopted Global Compact for Migration assuming mainstreaming migration into development planning at promoting sustainable development, if it would foresee planning development holistic by the model with migration tackled under subject equality SDG10&SDGs1-9, and with GCM as core of global managed sustainable development&cooperation structure to be merged with similar subject related agreements&structures on E&C as New Urban Agenda and Paris Agreement, Human Rights/Law (also Peace), and Support by the UN System including GPEDC with use of HDI and ODA, also global platforms. I would like to propose the model to a disposal of the United Nations, next to the Pope.

The model of 2016 would need renewed verification mainly of keeping E&C system. Its core version of 2004, regarding findings of Maslov, Kotler, Kline&Rosenberg, Authors of CNAM, of managed institutional development referred to territory&individuals at assumed equality&most effectiveness&support, attributed EU knowledge-based strategy, policies and equalizing&structuring R&D-teaching/education-regional programs, was verified by global science, appreciated by global auditor&stock exchange; accepted for doing EU regional pilot by EU Programs projects, which I did 2000-10 by regional University and its Regional Contact Point of EU R&D Program acting in national&EU network (building structure of my region in partnership with EU regions, EU manufacturing network&global leader aimed at own&common EU development and demonstration of support of EU employability of graduates at strong EU also UN-referred promotion and regional higher education). Full model underpins fundamentally the core one and completes interlinks of institutional system with individuals and E&C.
