

Summary points of digital governance discussion

The discussion on digital governance touched on the following interlinked areas:

1. The digital aspects of the governance systems, which enable societies to function – the ‘foundational’ and ‘functional’ systems, the sectoral and the ‘whole of government’ aspects.
2. Digital and democratic governance systems – how digital is changing democratic governance, for example, the opportunities and challenges around different forms of representative governance (both old and new).
3. The governance of the digital - how the principles, norms and objectives of the UN should be applied to the rapidly evolving digital sphere to ensure inclusive and rights-based social contracts, and what UNDP’s role in this is.
4. Due to I. and II. (and other reasons) we struggle to have a coherent conversation around these issues and, as mentioned by Robert Opp in his concluding remarks, work out what our organizational position should be. As noted by many participants, this is an urgent conversation.

About the event

Around the world digital technologies are redefining the relationships between the state and different forces and interests in society. These trends have been further amplified with the onset of COVID-19, highlighting the importance of privacy and data protection legislation, civil registration and national identity coverage, and reducing digital inequalities both within and between countries.

The event will provide a venue to collectively explore the role of digital governance in building new social contracts and highlight perspectives on pressing policy debates in the digital governance space, including approaches to address the impacts of COVID-19. We will consider how digital technologies can be leveraged to achieve inclusive service delivery, expand civic space and reduce inequalities, including the ‘digital divide’. We seek your views on the key issues that we should be taking into account as we further develop our offer.
