Defining roles of different stakeholders for each outcome envisaged


Avoid duplication, as there are already a high number of initatives. In particular refer to ITU-T regarding standards.

We also need training programs online for diplomats, but for this, there must be some type of catalytic funds provided. World Harmony Foundation already has put some of this together.



How should CODES manage the scope of potential interventions?









Identify major related efforts and don't duplicate effort.

Identify major barriers and use those to determine focus

Form Common Language for digital Environment Sustainability Tell a precise narrative and then focus on some institutional and procedural recommendations

Make sure to include all stakeholders into the discussion (I see the danger of lack of representation of civil society here)

It is an agenda setting quest - we can be broad - let's not miss anything (we can be redundant but we must take everyone along) CODES would do well and point to the future, UNEA 5.1, UNEP + 50 and Stockholm + 50 are logical places of entry to bring to more people and sectors

Developing an heuristic for each field of transformation; invite many others to make it more concrete Would drive a global debate

Vision and Identity of People to Engagement in different roles



Show clear added value for engagement with CODES so it is immediately relatable to the diverse stakeholder groups

Create a centralized agile process and repository that different actors can use on individual goals

Rank priorities

Always link to environment - other areas like connectivity, etc., CODES should then contribute/ask members to contribute to other areas or link environmental experts to other groups with the UN system.

Perhaps as we did for the original UNFI -- create a questionnaire for different stakeholders in the diamond formation of yesterday

Don't ride the hype too heavy. Clarify priorities: a sustainable future is the end, tech can be a means

Match digital and physical sustainability

Reinforce cooperation among stakeholders and facilitate and stimulate a more integrated approach on this common understanding

See where industry and investment can be directed - these global issues needed funding, it can help with implementation and really drive change and the sustainable transition.



Take a global view with a digital twin of Earth.

More international cooperation between different actors

Identify stakeholders that at the regional level to provide oversight and monitor actions required to roll out.

Clarify Long-term V Short-term objectives and goals. Ensure ALL objectives are aligned despite their differing goals.

Establish a network of networks. Work with the UN Playing 4 the Planet Alliance and others to amplify efforts

Involve people

CODES should not only focus on 'popular' choices by members, but should have a stronger focus on its ultimate goal which involves promoting a collaborative approach across the UN, with help from key partners and stakeholders in ACHIEVING THE SDGs.

Working from the SDGs backwards will help redirect focus and link to ultimate goals. The environment is a crosscutting goal and understanding how it links to all the SDGs and how technology comes in is key. CODES results should link to SDGs.

Create a Work Breakdown Structure. validate and control via keep performance indicator against goal, time line, resources and continues continuous development for iteration


