

UNDP RBAP Strategic Foresight Week 2022: reimagining ways to Decide, Design, and Deliver.

5 sessions and 3 days, 19-21 January 2022!

How can UNDP be fit for the future? In 2021 the Strategy, Policy and Partnerships (SPP) unit's Strategic Foresight portfolio has been testing approaches to this question.

The Asia-Pacific region is a fast growing, fast adapting region. To stay ahead, organisations of the future will need new methods to support strategy and planning to anticipate these crises and mitigate risks. The ability to be anticipatory - to act in preparation of 'what could happen' - is the learned skill and application of foresight, and is a bedrock of the Secretary-General's **Our Common Agenda** report.

The Foresight portfolio is developing an evolved offering of applying Strategic Foresight into the ways in which we decide, design, and deliver programmes. This means getting better at systematically looking and planning for what is ahead to manage complexity. In partnership with our pioneer country offices, we have developed accessible Foresight approaches that can be implemented by country offices for their Country Office Business Plans (COBP) Country Programme Documents (CPDs), and Project document design (ProDoc).

Approach and Objective

You're invited to the inaugural RBAP Foresight Week from 19 – 21 January 2022! Over the course of 3 days and 5 action-packed virtual sessions, we will explore a Strategic Foresight package put together by SPP (Strategy, Partnership & Policy), that COs can employ in 2022 for anticipatory planning. We have timed our event in January so that COs can use insights for programme planning and begin embedding foresight processes.
